

The Doggie Spot - Daycare and Boarding Contract

I certify the following:

- 1) I am the pet owner (Owner) of _____ (name), a _____ (color), _____ (breed), County Tag# _____;

- 2) My dog is in good health, has been spayed or neutered, and has not been ill with any communicable condition in the last 30 days;
- 3) My dog has not harmed or shown overtly aggressive or threatening behavior towards any person or any other dog;
- 4) It is my responsibility to provide The Doggie Spot Staff with a veterinarian's confirmation of my dog's health, temperament and vaccinations;
- 5) I am solely responsible for any harm caused by my dog to property, any person or any other dog while my dog is attending The Doggie Spot.

I understand and agree:

- 1) Due to the nature of dog daycare my dog will have close contact with other dogs;
- 2) There are certain inherent risks involved in participating in dog day care, that every dog reacts differently and by nature are unpredictable;
- 3) The Doggie Spot staff will not knowingly admit into the play area dogs that are obviously aggressive or ill;
- 4) In the event a dog acts out of character or unpredictably and my dog is injured under no circumstances will The Doggie Spot be liable for damages. On behalf of myself, my heirs and any assigns, I hereby release The Doggie Spot, its agents, officers, subcontractors, employees, animal parents, customers and potential customers of The Doggie Spot from any and all liabilities for injuries to myself, my dog, or any other property of mine which arise in any way out of services and/or products provided by or as a consequence of my association with The Doggie Spot.

If my dog is injured, becomes seriously ill, or the state of my dog's health otherwise requires professional attention while at The Doggie Spot, the Doggie Spot staff, in its sole discretion, may engage the services of a local veterinarian. I hereby give my consent and authorization to The Doggie Spot staff to act on my behalf to transport my dog and obtain veterinary care for my dog. By my signature below, I authorize the veterinarian to provide medical and/or surgical treatment for my dog. I agree to pay for any fees, which may result from said treatment services. The Doggie Spot is not liable for the location, treatment or diagnosis of any injuries incurred on our premises. It is recommended you check your dog further or seek treatment for your pet by a licensed veterinarian at your discretion and cost.

I have read the current schedule of fees and times of service (Schedule), which is attached and incorporated herein. I agree:

- 1) To pay fee charges at the time of my dog's check-in at The Doggie Spot unless other written arrangements have been made;
- 2) My dog will be picked up by me the Owner or by another person approved by me by the close of business. If my dog is picked up after the stated time of close of business, I will pay any additional charges set forth by The Doggie Spot.;
- 3) If my dog shows any signs of fleas or ticks during its stay, The Doggie Spot may bathe and flea dip my dog and I will be charged accordingly;
- 4) If my dog's nails are deemed to be a length that may pose a danger to a person or another dog, The Doggie Spot may clip my dog's nails, and I will be charged accordingly;
- 5) All charges must be paid prior to my dog's checkout;
- 6) If a balance remains for 30 days or more my account will be referred for collection action and as a result, I will be liable for collection costs (inclusive of statutory allowable interest) and legal fees, in addition to the unpaid balance;
- 7) _____ I authorize The Doggie Spot to charge my credit card account for any outstanding invoices;
- 8) The fees are subject to change and this contract will be binding for subsequent Schedules.

I hereby give my permission to copyright and/or use, reuse and/or publish or post pictures of my dog in color or black and white made through any media by The Doggie Spot for use in print material, electronic media or internet usage for use in advertising The Doggie Spot.

I have read and understand The Doggie Spot Rules and Regulations.

I understand that The Doggie Spot has the right to refuse service at any time, for any reason, to any dog.

It is understood by The Doggie Spot and Owner that all provisions of this Contract shall be binding upon both parties for this visit and for all subsequent visits to The Doggie Spot.

With my signature below, I accept exclusive and sole responsibility (financial and otherwise) for these and all other risks and release The Doggie Spot of all liability, no matter the cause.
